Lisa Anderson

Lisa Anderson is Special Lecturer and James T. Shotwell Professor of International Relations Emerita at the Columbia University Columbia University

Dr. Anderson served as President of the American University in Cairo for five years, from 2011-2016. Prior to her appointment as President, she was the University's provost, a position she had assumed in 2008. She is Dean Emerita of the School of International and Public Affairs at Columbia, where she led the school from 1997-2007. She was on the faculty of Columbia since 1986; prior to her appointment as Dean, she served as Chair of the Political Science Department and Director of Columbia's Middle East Institute. She has also taught at Princeton and Harvard Universities.

Sean Yom

Associate Professor of Political Science Temple University. Sean Yom is Associate Professor of Political Science at Temple University and Senior Fellow in the Middle East Program at the Foreign Policy Research Institute. He is a specialist on regimes and governance in the Middle East, especially in Arab monarchies like Jordan. Kuwait, and Morocco. His research engages topics of authoritarian politics, democratic reforms, institutional stability, and economic development in these countries, as well as their implications for US foreign policy. His publications include the books From Resilience to Revolution: How Foreign Interventions Destabilize the Middle East (Columbia University Press, 2016), as well as Government and Politics of the Middle East and North Africa, 9th edition (Routledge, 2020); articles in print journals like Comparative Political Studies, European Journal of International Relations, Studies in Comparative International Development, and Journal of Democracy; and contributions in online venues like Foreign Affairs, Middle East Eye, and the Washington Post's Monkey Cage. He also advises country-level work with international NGOs, law firms, and sovereign clients. Education: A.B., Brown University (2003); PhD., Harvard University (2009).

Adham Saouli

Professor of Politics and International Relations Doha Institute for Graduate Studies. Adham Saouli is Professor of Politics and International Relations and Head of the Critical Security Studies program. He joined the Doha Institute for Graduate Studies in September 2023. Saouli has held a Post-Doctoral Research Fellowship at the University College Dublin (2008-2009) and Lectureship (Assistant Professorship) at the University of Edinburgh (2009-2014). He moved to the University of St Andrews in 2014 and was promoted to Professor of International Relations in 2022. Saouli is a member of the Arab Political Science Network, APSA, MESA, BISA, and BRISMES. He is the Founding-Editor of Disruptions, a book series on social movements, revolutions, and activism that is published by Edinburgh University Press and is on the editorial board of Siyasat Arabia.

May Darwich

Associate Professor in International Relations of the Middle East-University of Birmingham.May Darwich is Associate Professor in International Relations of the Middle East at the University of Birmingham. She was Assistant Professor at Durham University (2016-2019) and a Research Fellow at GIGA German Institute of Global and Area Studies (2014-2015).

Her research attempts to bring Middle East cases to debates within IR theory while surmounting the challenge to the study of state behaviour in the Middle East through theoretical lenses. Her research has appeared in internationally renowned journals, namely Foreign Policy Analysis, the Journal of Global Security Studies,

Democratization, Mediterranean Politics, Global Discourse and in volumes on the international relations of the Middle East. She is author of Threats and Alliances in the Middle East: Saudi and Syrian Policies in a Turbulent Region (Cambridge University Press, 2019). She is Principal Investigator of the Carnegie-funded project Port Infrastructures, International Politics, and Everyday Life: From the Arabian Gulf to the Horn of Africa.
